Short Title: Operation Coming Home Special Plate. (Public)

Sponsors: Senator Hunt (Primary Sponsor).

1 A BILL TO BE ENTITLED  
2 AN ACT TO AUTHORIZE THE DIVISION OF MOTOR VEHICLES TO PRODUCE A  
3 SPECIAL REGISTRATION PLATE FOR OPERATION COMING HOME, INC.

4 The General Assembly of North Carolina enacts:

5 **SECTION 1.** G.S. 20-79.4(b) is amended by adding a new subdivision to read:

6 "(b) Types. – The Division shall issue the following types of special registration plates:

7 ...

8 () Operation Coming Home. – Issuable to the registered owner of a motor  
9 vehicle in accordance with G.S. 20-81.12. The plate shall bear the phrase  
10 "Operation Coming Home" with a logo designed by Operation Coming  
11 Home, Inc.

12 ...."

13 **SECTION 2.** G.S. 20-79.7(a) reads as rewritten:

14 "§ 20-79.7. Fees for special registration plates and distribution of the fees.

15 (a) Fees. – Upon request, the Division shall provide and issue free of charge a single  
16 Legion of Valor, 100% Disabled Veteran, and Ex-Prisoner of War registration plate to a  
17 recipient of a Legion of Valor award, a 100% disabled veteran, and an ex-prisoner of war each  
18 year. The preceding special registration plates are subject to the regular motor vehicle  
19 registration fees in G.S. 20-88, if the registered weight of the vehicle is greater than 6,000  
20 pounds. All other special registration plates are subject to the regular motor vehicle registration  
21 fee in G.S. 20-87 or G.S. 20-88 plus an additional fee in the following amount:

28 **SECTION 3.** G.S. 20-79.7(b) reads as rewritten:

29 "(b) Distribution of Fees. – The Special Registration Plate Account and the Collegiate  
30 and Cultural Attraction Plate Account are established within the Highway Fund. The Division  
31 must credit the additional fee imposed for the special registration plates listed in subsection (a)  
32 of this section among the Special Registration Plate Account (SRPA), the Collegiate and  
33 Cultural Attraction Plate Account (CCAPA), the Natural Heritage Trust Fund (NHTF), which  
34 is established under G.S. 113-77.7, and the Parks and Recreation Trust Fund, which is  
35 established under G.S. 113-44.15, as follows:

6           **SECTION 4.** G.S. 20-81.12 is amended by adding a new subsection to read:

7           "(b126) Operation Coming Home. – The Division must receive 300 or more applications  
8 for an "Operation Coming Home" plate before the plate may be developed. The Division shall  
9 transfer quarterly the money in the Collegiate and Cultural Attraction Plate Account derived  
10 from the sale of "Operation Coming Home" plates to the Operation Coming Home Foundation,  
11 Inc., to support its mission of providing free, custom-built homes to injured combat veterans."

12           **SECTION 5.** This act becomes effective July 1, 2013.
