1 A BILL TO BE ENTITLED
2 AN ACT TO REPEAL OUTDATED AND OBSOLETE DEPARTMENT OF
3 TRANSPORTATION REPORTING REQUIREMENTS.

4 The General Assembly of North Carolina enacts:

5 **SECTION 1.** G.S. 136-44.9 is repealed.

6 **SECTION 2.** G.S. 136-200.2(a) reads as rewritten:

7 "**§ 136-200.2. Decennial review of metropolitan planning organization boundaries,**
8 **structure, and governance.**

9 (a) Evaluation. – Following each decennial census, and more frequently if requested by
10 an individual metropolitan planning organization, the Governor and the Secretary of
11 Transportation, in cooperation with the affected metropolitan planning organization or
12 organizations, shall initiate an evaluation of the boundaries, structure, and governance of each
13 metropolitan planning organization in the State. The goal of the evaluation shall be to examine
14 the need for and to make recommendations for adjustments to metropolitan planning
15 organization boundaries, structure, or governance in order to ensure compliance with the
16 objectives of 23 U.S.C. § 134. ~~The Secretary shall submit a report of the evaluation process to~~
17 ~~the Governor and to the Joint Legislative Transportation Oversight Committee.~~

19 **SECTION 3.** G.S. 136-202(d) is repealed.

20 **SECTION 4.** G.S. 143-215.107C(e) reads as rewritten:

21 "**§ 143-215.107C. State agency goals, plans, duties, and reports.**

22 ...

23 (e) The Department of Transportation, the Department of Commerce, and the
24 Department of Environment and Natural Resources shall jointly develop and periodically
25 update a plan to reduce vehicle miles traveled by private sector employees and vehicle
26 emissions resulting from job-related travel, including commuting to and from work. The plan
27 shall consider the use of incentives for both private sector employees and employers to promote
28 carpooling, vanpooling, use of public transportation, and other appropriate strategies. ~~The~~
29 ~~Department of Transportation shall report on the development and implementation of the plan~~
30 ~~to the Joint Legislative Transportation Oversight Committee and the Environmental Review~~
31 ~~Commission on or before 1 October of each year beginning 1 October 2000."~~
