A BILL TO BE ENTITLED

1 AN ACT TO APPOINT PERSONS TO VARIOUS PUBLIC OFFICES UPON THE
2 RECOMMENDATION OF THE PRESIDENT PRO TEMPORE OF THE SENATE AND
3 THE SPEAKER OF THE HOUSE OF REPRESENTATIVES AND TO APPOINT A
4 MEMBER OF THE BOARD OF DIRECTORS FOR THE NORTH CAROLINA
5 PARTNERSHIP FOR CHILDREN, INC., UPON THE RECOMMENDATION OF THE
6 MAJORITY AND MINORITY LEADERS OF THE HOUSE OF REPRESENTATIVES.

8 Whereas, G.S. 120-121 authorizes the General Assembly to make certain
9 appointments to public offices upon the recommendation of the President Pro Tempore of the
10 Senate and the Speaker of the House of Representatives; and

11 Whereas, the President Pro Tempore of the Senate and the Speaker of the House of
12 Representatives have made recommendations; and

13 Whereas, G.S. 143B-168.12 authorizes the General Assembly to appoint a member
14 of the public to the Board of Directors of the North Carolina Partnership for Children, Inc.,
15 upon recommendation of the Majority and Minority Leaders of the House of Representatives;
16 and

17 Whereas, the Majority and Minority Leaders of the House of Representatives have
18 made recommendations; Now, therefore,
19 The General Assembly of North Carolina enacts:
