Short Title: Education Innovation Task Force. (Public)

Sponsors: Representatives Elmore, S. Martin, Horn, and Cotham (Primary Sponsors).

Referred to:

1 A BILL TO BE ENTITLED
2 AN ACT TO ESTABLISH THE LEGISLATIVE TASK FORCE ON EDUCATION
3 INNOVATION, AS RECOMMENDED BY THE HOUSE STUDY COMMITTEE ON
4 EDUCATION INNOVATION.

5 The General Assembly of North Carolina enacts:

6 **SECTION 1.** There is created the Legislative Task Force on Education Innovation.

7 **SECTION 2.** The Task Force shall consist of 19 members as follows:

8 (1) Nine members appointed by the President Pro Tempore of the Senate as
9 follows:

10 a. Five persons who are members of the Senate at the time of
11 appointment.

12 b. A school system superintendent.

13 c. A school system principal.

14 d. A public school teacher.

15 e. A parent of a student who is enrolled in a public school.

16 (2) Nine members appointed by the Speaker of the House of Representatives as
17 follows:

18 a. Five persons who are members of the House of Representatives at
19 the time of appointment.

20 b. A school system superintendent.

21 c. A school system principal.

22 d. A public school teacher.

23 e. A parent of a student who is enrolled in a public school.

24 (3) The 2015 North Carolina Teacher of the Year.

25 **SECTION 3.** The Speaker of the House of Representatives shall designate one
26 Representative as cochair, and the President Pro Tempore of the Senate shall designate one
27 Senator as cochair. Vacancies on the Task Force shall be filled by the same appointing
28 authority that made the initial appointment. A quorum of the Task Force shall be a majority of
29 its members.

30 **SECTION 4.** The Task Force shall study the need to create a permanent entity
31 dedicated to examining innovative practices in education designed to improve student
32 achievement throughout the State. As part of this study, the Task Force shall do the following:

33 (1) Examine whether a permanent entity to study education innovation is the
34 appropriate platform for the consideration of emerging innovations in
35 education and for providing recommendations to the General Assembly on



1 the incorporation of innovative practices in the public schools and higher
2 education, including the use of State funds to advance this purpose.

3 (2) Examine the appropriate structure for a permanent entity to study education
4 innovation, including membership of the entity, housing of the entity in an
5 agency or in the legislative branch, stakeholder participation in the
6 membership and duties of the entity, and staffing of the entity.

7 (3) Gather information from stakeholders in the areas of public schools and
8 higher education on the establishment of a permanent entity to study
9 education innovation.

10 (4) Study any other issues the Task Force considers relevant.

11 **SECTION 5.** The Task Force, while in the discharge of its official duties, may
12 exercise all powers provided for under G.S. 120-19 and G.S. 120-19.1 through G.S. 120-19.4.
13 The Task Force may meet at any time upon the joint call of the cochairs. The Task Force may
14 meet in the Legislative Building or the Legislative Office Building.

15 With approval of the Legislative Services Commission, the Legislative Services
16 Officer shall assign professional staff to assist the Task Force in its work. The House of
17 Representatives' and the Senate's Directors of Legislative Assistants shall assign clerical staff to
18 the Task Force, and the expenses relating to the clerical employees shall be borne by the Task
19 Force. The Task Force may contract for professional, clerical, or consultant services as
20 provided by G.S. 120-32.02. If the Task Force hires a consultant, the consultant shall not be a
21 State employee or a person currently under contract with the State to provide services.

22 All State departments and agencies and local governments and their subdivisions
23 shall furnish the Task Force with any information in their possession or available to them.

24 **SECTION 6.** The Task Force shall submit a final report of the results of its study
25 and its recommendations, including any proposed legislation, to the 2017 General Assembly.
26 The Task Force shall terminate on December 31, 2016, or upon the filing of its final report,
27 whichever occurs first.

28 **SECTION 7.** This act is effective when it becomes law.
