Short Title: Strengthen Military in NC/Mitigate BRAC Risk. (Public)

1 A BILL TO BE ENTITLED
2 AN ACT TO STRENGTHEN AND PROTECT THE NORTH CAROLINA NATIONAL
3 GUARD AND ACTIVE AND RESERVE COMPONENTS OF THE ARMED FORCES.

4 Whereas, North Carolina has the fourth largest population of military personnel of
5 any state; and

6 Whereas, the military is the second largest sector of North Carolina's economy; and

7 Whereas, a failure to adequately strengthen and protect the military in this State
8 would make military installations in the State vulnerable to closure under the ongoing federal
9 Base Realignment and Closure initiative; and

10 Whereas, U.S. Northern Command's (Homeland Defense Command) most exercised
11 mission is Defense Support of Civil Authority; otherwise known as Civil Support where
12 Active, Reserve, and National Guard military capabilities support civilian emergency response
13 agencies to save lives, prevent human suffering, and mitigate great property damage during
14 natural and manmade disasters; and

15 Whereas, the North Carolina National Guard is the only organized, trained, and
16 equipped military force subject to the control of the State; and

17 Whereas, the General Assembly established the National Guard Tuition Assistance
18 Program to encourage voluntary membership in the North Carolina National Guard and to
19 improve the educational achievement of its members; and

20 Whereas, the General Assembly recognizes that the North Carolina National Guard
21 acts in the interests of the State of North Carolina and the United States not only while at its
22 home stations but also in locations around the world; and

23 Whereas, in cooperation with the United States Department of State and the United
24 States Department of Defense, the North Carolina National Guard has enhanced the relations of
25 the United States with National Guard State Partnership Program participants such as the
26 Republic of Moldova and the Republic of Botswana; and

27 Whereas, such partnerships go beyond military-to-military cooperation and extend
28 into multiple disciplines including agriculture, higher education, health care, democracy
29 promotion, law enforcement, disaster response, and many others as the North Carolina National
30 Guard also facilitates civilian-to-civilian relationships between the people of North Carolina
31 and partner nations; and

32 Whereas, the General Assembly recognizes that the Adjutant General of North
33 Carolina is often called on to represent the State Partnership Program engagements both at
34 home and abroad; Now, therefore,

35 The General Assembly of North Carolina enacts:

1 **SECTION 1.** There is appropriated from the General Fund to the Department of
2 Agriculture and Consumer Services the sum of ten million dollars (\$10,000,000) for the
3 2015-2016 fiscal year to complete acquisition of the real property known as the Headwaters
4 Tract in Transylvania County, which will support training and support missions that improve
5 safety, support the effectiveness and efficiency of governmental agencies, and enhance
6 emergency response capabilities and other capabilities to better serve the citizens of North
7 Carolina and the nation and in the process enhance the local economy of the region.

8 **SECTION 2.** There is appropriated from the General Fund to the Department of
9 Public Safety the sum of two hundred thousand dollars (\$200,000) for the 2015-2016 fiscal
10 year and the sum of two hundred thousand dollars (\$200,000) for the 2016-2017 fiscal year for
11 the Tuition Assistance Program of the North Carolina National Guard.

12 **SECTION 3.(a)** There is appropriated from the General Fund to the Department of
13 Public Safety the sum of six hundred eighteen thousand dollars (\$618,000) for the 2015-2016
14 fiscal year and the sum of five million eighty-seven thousand five hundred one dollars
15 (\$5,087,501) for the 2016-2017 fiscal year for expansion and rehabilitation of the North
16 Carolina National Guard armories in Elizabeth City, Jacksonville, Louisburg, and Reidsville.
17 These funds will provide a State match for an estimated six million nine hundred five thousand
18 five hundred one dollars (\$6,905,501) in federal funds, and those funds are hereby
19 appropriated.

20 **SECTION 3.(b)** No later than April 30, 2016, and annually thereafter until the
21 projects authorized by subsection (a) of this section are complete, the North Carolina National
22 Guard shall report on the status of the projects to the Joint Legislative Oversight Committee on
23 Justice and Public Safety.

24 **SECTION 4.** There is appropriated from the General Fund to the Department of
25 Public Safety the sum of four hundred ninety-eight thousand eight hundred seventy-five dollars
26 (\$498,875) for the 2015-2016 fiscal year and the sum of four hundred ninety-eight thousand
27 eight hundred seventy-five dollars (\$498,875) for the 2016-2017 fiscal year to operate the
28 Stanly County campus of the Tarheel Challenge Academy. These funds will provide a State
29 match for federal funds that have been made available for this purpose and those funds are
30 hereby appropriated.

31 **SECTION 5.** The Adjutant General of the North Carolina National Guard is hereby
32 recognized as an ambassador of the State of North Carolina, and there is appropriated from the
33 General Fund to the Department of Public Safety the sum of three thousand five hundred
34 dollars (\$3,500) for the 2015-2016 fiscal year and the sum of three thousand five hundred
35 dollars (\$3,500) for the 2016-2017 fiscal year to provide meals, refreshments, and gifts at
36 official receptions involving diplomats of the United States or other international partners. Any
37 gifts received by the Adjutant General shall be State property and shall be archived and
38 recorded for historical purposes.

39 **SECTION 6.** There is appropriated from the General Fund to the Department of
40 Agriculture and Consumer Services the sum of two hundred fifty thousand dollars (\$250,000)
41 for the 2015-2016 fiscal year to plan a North Carolina National Guard facility to be located
42 within the 420 acreage surrounding the latitude/longitude point 35°11.0994'N – 082°37.1166'W.
43 The Department shall consult with the North Carolina National Guard in the design and site
44 selection of the facility.

45 **SECTION 7.** This act becomes effective July 1, 2015.
