7	(1) RULE 1 shall read as follows: "RULE 1. Convening Hour. The House shall		
8		convene each legislative day at the hour fixed by the House. In the event the		
9		House adjourns on the preceding legislative day without having fixed an hour		
10		for reconvening, the House shall convene on the next legislative day at 10:00		
11		A.M."

1	(8)	Notwithstanding RULE 38(c), a bill may be referred to the Standing Committee
2		on Appropriations or the Standing Committee on Finance with unengrossed
3		amendments.
4	(9)	Notwithstanding RULE 41:
5		a. The first reading and reference to a standing committee of a House bill
6		shall occur on the legislative day of its introduction. The first reading
7		and reference to a standing committee of a Senate bill shall occur on the
8		legislative day of its receipt on messages from the Senate. The Speaker
9		shall give notice at each subsequent reading whether it is the second or
10		third reading.
11		b. When a bill or resolution has passed its second reading, it shall be
12		placed on the calendar for immediate consideration on its third reading,
13		unless prohibited by Section 23 of Article II of the North Carolina
14		Constitution.
15	(10)	Notwithstanding RULE 44(d), a conference report may be placed on the
16		calendar for the legislative day on which the report is received.
17	(11)	Notwithstanding RULE 44.1, all bills shall be sent by special message to the
18		Senate and all ratified bills subject to gubernatorial veto shall be sent by special
19		message to the Governor.
20	(12)	Notwithstanding RULE 44.2, a vote may be taken on overriding a gubernatorial
21		veto on a House or Senate bill the same legislative day of notice of its
22		placement on the calendar.
23	(13)	Notwithstanding RULE 59, any member wishing to cosponsor a bill or
24		resolution that has been introduced may do so on the day during which the bill
25		or resolution was first read and referred, but only while the bill or resolution is
26		in the possession of the House.
