A BILL TO BE ENTITLED

AN ACT TO ADVANCE ECONOMIC SECURITY IN NORTH CAROLINA BY INCREASING THE STATE MINIMUM WAGE IN PHASES TO FIFTEEN DOLLARS PER HOUR OVER FIVE YEARS, MANDATING EQUAL PAY FOR EQUAL WORK, REQUIRING PAID SICK LEAVE AND FAMILY MEDICAL LEAVE, INCREASING THE TIPPED MINIMUM WAGE, ENDING WAGE THEFT, REQUIRING THE FAIR ASSESSMENT OF PERSONS WITH CRIMINAL HISTORIES BY "BANNING THE BOX," REPEALING PUBLIC EMPLOYEE COLLECTIVE BARGAINING RESTRICTIONS, AND REENACTING THE EARNED INCOME TAX CREDIT AND TAX CREDITS FOR CHILD CARE AND CERTAIN EMPLOYMENT-RELATED EXPENSES.

The General Assembly of North Carolina enacts:

**LIVING WAGE**

**SECTION 1.1.** G.S. 95-25.3(a) reads as rewritten:

**"§ 95-25.3. Minimum wage.**

(a) Every employer shall pay to each employee who in any workweek performs any work, wages of at least ~~six dollars and fifteen cents (\$6.15) per hour or the minimum wage set forth in paragraph 1 of section 6(a) of the Fair Labor Standards Act, 29 U.S.C. 206(a)(1), as that wage may change from time to time, whichever is higher, except as otherwise provided in this section.~~ the following amounts:

- (1) Effective on Labor Day, September 1, 2017, eight dollars (\$8.00) per hour or the minimum wage set forth in paragraph 1 of section 6(a) of the Fair Labor Standards Act, 29 U.S.C. § 206(a)(1), as that wage may change from time to time, whichever is higher, except as otherwise provided in this section.
- (2) Effective on Labor Day, September 1, 2018, nine dollars and fifty cents (\$9.50) per hour or the minimum wage set forth in paragraph 1 of section 6(a) of the Fair Labor Standards Act, 29 U.S.C. § 206(a)(1), as that wage may change from time to time, whichever is higher, except as otherwise provided in this section.
- (3) Effective on Labor Day, September 1, 2019, eleven dollars (\$11.00) per hour or the minimum wage set forth in paragraph 1 of section 6(a) of the Fair Labor Standards Act, 29 U.S.C. § 206(a)(1), as that wage may change from time to time, whichever is higher, except as otherwise provided in this section.
- (4) Effective on Labor Day, January 1, 2020, thirteen dollars (\$13.00) per hour or the minimum wage set forth in paragraph 1 of section 6(a) of the Fair Labor



1 Standards Act, 29 U.S.C. § 206(a)(1), as that wage may change from time to  
2 time, whichever is higher, except as otherwise provided in this section.  
3 (5) Effective on Labor Day, January 1, 2021, fifteen dollars (\$15.00) per hour or  
4 the minimum wage set forth in paragraph 1 of section 6(a) of the Fair Labor  
5 Standards Act, 29 U.S.C. § 206(a)(1), as that wage may change from time to  
6 time, whichever is higher, except as otherwise provided in this section."

## 8 EQUAL PAY FOR EQUAL WORK

9 SECTION 2.1. Chapter 95 of the General Statutes is amended by adding a new  
10 Article to read:

11 "Article 2B.

12 "Equal Pay Act.

### 13 "§ 95-25.26. Definitions.

14 The following definitions apply in this Article:

- 15 (1) Employee. – Every woman or man in receipt of or entitled to compensation for  
16 labor performed for another.  
17 (2) Employer. – Includes (i) this State and any local political subdivision of the  
18 State and (ii) every person having control or direction of any woman or man  
19 employed at any labor, or responsible directly or indirectly for the wages of  
20 another, who employs more than five employees.  
21 (3) Person. – As defined by G.S. 95-25.2(11).  
22 (4) Wage or wages. – Any compensation for labor measured by time, piece, or  
23 otherwise.

### 24 "§ 95-25.27. Equal wage rates.

25 (a) No employer shall pay any person in the employer's employ at wage rates less than the  
26 rates paid to employees of the opposite sex in the same establishment for the same quantity and  
27 quality of the same classification of work. Any employer who violates this section is liable to the  
28 employee affected in the amount of the wages that the employee is deprived by reason of the  
29 violation.

30 (b) Notwithstanding the provisions of subsection (a) of this section, nothing in this section  
31 prohibits a variation of rates of pay for male and female employees engaged in the same  
32 classification of work based upon seniority, a difference in length of service, ability, skill,  
33 difference in duties or services performed, whether regularly or occasionally, difference in the  
34 shift or time of day worked, hours of work, or restrictions or prohibitions on lifting or moving  
35 objects in excess of specified weight, or other reasonable differentiation, or factor or factors other  
36 than sex, when exercised in good faith.

37 (c) An employer that is in violation of this section may not reduce the pay of any  
38 employee in order to bring the employer into compliance with this Article.

39 (d) An employer shall not retaliate against any employee who seeks redress pursuant to  
40 this Article or who participates in the investigation of a complaint under this Article.

### 41 "§ 95-25.28. Complaints; enforcement; civil actions.

42 (a) An affected employee may file with the Department of Labor a complaint that the  
43 wages paid to the employee are less than the wages to which the employee is entitled under this  
44 Article. The Department of Labor shall investigate the complaint and notify the employer and  
45 employee of the results of the investigation.

46 (b) An employee receiving less than the wage to which the employee is entitled under this  
47 section may recover in a civil action the balance of such wages, together with the costs and  
48 attorneys' fees, notwithstanding any agreement to work for a lesser wage. The employee is not  
49 required to exhaust administrative remedies before filing the civil action.

50 (c) A civil action pursuant to this section shall be instituted within two years after the date  
51 that the alleged violation is discovered by the affected employee."

2 **PAID SICK AND FAMILY MEDICAL LEAVE**

3 **SECTION 3.1.(a)** Chapter 95 of the General Statutes is amended by adding a new  
4 Article to read:

5 "Article 3A.

6 "Healthy Families and Healthy Workplaces Act.

7 **"§ 95-31.1. Short title and legislative purpose.**

8 (a) This Article shall be known and may be cited as the "Healthy Families and Healthy  
9 Workplaces Act."

10 (b) The public policy of this State is declared as follows: The health and safety needs of  
11 employees and their families and the protection of employees from losing their jobs and pay while  
12 they seek medical care for themselves and their family members are subjects of concern requiring  
13 legislation to promote the general welfare of the people of the State without jeopardizing the  
14 competitive position of North Carolina business and industry. The General Assembly declares that  
15 the general welfare of the State requires the enactment of this law under the police power of the  
16 State.

17 **"§ 95-31.2. Definitions.**

18 (a) The following definitions apply in this Article:

19 (1) Child. – A biological, adopted, or foster child, stepchild, legal ward, or child of  
20 a parent standing in loco parentis who is under 18 years of age, or 18 years of  
21 age or older but incapable of earning wages because of a mental or physical  
22 incapacity.

23 (2) Domestic violence. – As defined in G.S. 50B-1.

24 (3) Employ. – As defined by G.S. 95-25.2(3).

25 (4) Employee. – As defined by G.S. 95-25.2(4).

26 (5) Employer. – As defined by G.S. 95-25.2(5).

27 (6) Federal act. – The Family and Medical Leave Act of 1993, 29 U.S.C. §§ 2601  
28 to 2654 inclusive, as it may be amended.

29 (7) Health care provider. –

30 a. A doctor of medicine or osteopathy licensed to practice medicine in the  
31 State.

32 b. A physician assistant licensed in this State.

33 c. A family nurse practitioner licensed in this State.

34 (8) Immediate family member. – An employee's spouse, mother, father, brother,  
35 sister, son, daughter, grandmother, grandfather, grandson, or granddaughter,  
36 whether the relationship is a biological, foster, adoptive, step, half, or in-law  
37 relationship.

38 (9) Paid sick time or paid sick days. – Time that is (i) compensated at the same  
39 hourly rate and with the same benefits, including health care benefits, as the  
40 employee normally earns during hours worked and (ii) provided by an  
41 employer to an employee for the purposes described in G.S. 95-31.4(b) of this  
42 Article.

43 (10) Parent. – A biological, foster, stepparent, or adoptive parent of an employee or  
44 an employee's spouse, or other person who stood in loco parentis during the  
45 childhood of an employee or employee's spouse.

46 (11) Sexual assault. – As defined in Chapter 14 of the General Statutes.

47 (12) Small business. – An employer who employs 10 or fewer employees during 20  
48 or more calendar workweeks in the current or preceding calendar year.

49 (13) Stalking. – As defined in Chapter 14 of the General Statutes.

50 **"§ 95-31.3. Exemptions.**

1        (a) The provisions of this section do not apply to any bona fide volunteers in any  
2 organization where an employer-employee relationship does not exist.

3        (b) The provisions of this section do not apply to any person exempted from the Wage and  
4 Hour Act under G.S. 95-25.14(a)(2) through (8), G.S. 95-25.14(b), 95-25.14(b1), 95-25.14(c), and  
5 95-25.14(e), except that domestic workers are exempted only if they are employed in the place of  
6 residence of their employer.

7 **"§ 95-31.4. Accrual of paid sick time.**

8        (a) Except as provided by G.S. 95-31.3, any employee who works in this State and who  
9 must be absent from work for the reasons set forth in G.S. 95-31.5(a) shall be entitled to paid sick  
10 time.

11        (b) Paid sick time as provided in this section shall begin to accrue at the commencement of  
12 employment. Paid sick time shall accrue at the rate of one hour of pay for every 30 hours worked.  
13 Paid sick time may be used as accrued, or be loaned by the employer at its discretion, to the  
14 employee in advance of accrual. Unless the employer and employee agree to designate otherwise,  
15 for periods of paid sick time that are less than a normal workday, the time shall be counted on an  
16 hourly basis or the smallest increment that the employer's payroll system uses to account for  
17 absences or use of leave.

18        (c) For employees of small businesses, there shall be a limit of 32 hours of accrued paid  
19 time in a calendar year. For employees of other employers, there shall be a limit of 56 hours of  
20 accrued paid sick time in a calendar year. Accrued paid sick time for employees carries over from  
21 year to year but is limited to the aforementioned limits.

22        (d) When there is separation from employment and the employee is rehired within 90 days  
23 of separation by the same employer, previously accrued paid sick time that had not been used shall  
24 be reinstated. The employee shall be entitled to use accrued paid sick time and accrue additional  
25 sick time at the recommencement of employment.

26 **"§ 95-31.5. Use of paid sick time.**

27        (a) Paid sick time shall be provided to an employee by an employer for any of the  
28 following reasons:

29            (1) To care for the employee's immediate family member who is suffering from a  
30 physical or mental illness, injury, or medical condition that requires home care,  
31 professional medical diagnosis or care, preventative medical care, or a routine  
32 medical appointment, unless the care is covered under federal law.

33            (2) To care for the employee's own physical or mental illness, injury, or medical  
34 condition that requires home care, professional medical diagnosis or care,  
35 preventative medical care, or a routine medical appointment, unless the care is  
36 covered under federal law.

37            (3) To allow an employee to address the psychological, physical, or legal effects on  
38 himself or herself, or an immediate family member, of domestic violence,  
39 sexual assault, or stalking.

40        (b) An employer may require certification of the qualifying illness, injury, health  
41 condition, or violence when a paid sick time period covers more than three consecutive workdays.  
42 Any reasonable documentation signed by a health care provider involved in following or treating  
43 the illness, injury, or health condition, and indicating the need for the amount of sick days taken,  
44 shall be deemed acceptable certification. Acceptable certification of domestic violence, sexual  
45 assault, or stalking may include (i) law enforcement, court, or federal agency records or files; (ii)  
46 documentation from a domestic violence or sexual assault program; or (iii) documentation from a  
47 religious, medical, or other professional from whom assistance was sought in dealing with the  
48 alleged domestic violence, sexual offense, or stalking.

49            (1) The employer shall not require certification from a health care provider  
50 employed by the employer. The employer shall not delay the commencement of  
51 time taken for purposes of subsection (a) of this section or pay for this period

1           on the basis that the employer has not yet received the certification. Nothing in  
2           this section shall be construed to require an employee to provide as certification  
3           any information from a health care provider that would be in violation of  
4           section 1177 of the Social Security Act or the regulations promulgated pursuant  
5           to section 264(c) of the Health Insurance Portability and Accountability Act, 42  
6           U.S.C. § 1320d-2.

7           (2) An employer may not require disclosure of details relating to domestic  
8           violence, sexual assault, or stalking or the details of an employee's medical  
9           condition as a condition of providing paid sick time under this Article. If an  
10           employer possesses health information or information pertaining to domestic  
11           violence, sexual assault, or stalking about an employee or employee's  
12           immediate family member, such information shall be treated as confidential and  
13           not disclosed except to the affected employee or with the permission of the  
14           affected employee.

15           (c) When the use of sick time is foreseeable, the employee shall make a good-faith effort  
16           to provide notice of the need for such time to the employer in advance of the use of the sick time  
17           and shall make a reasonable effort to schedule the use of sick time in a manner that does not  
18           unduly disrupt the operations of the employer.

19           (d) An employer may not require, as a condition of providing sick time under this act, that  
20           the employee search for or find a replacement worker to cover the hours during which the  
21           employee is on paid sick time.

22           (e) Nothing in this section shall be construed as requiring financial or other reimbursement  
23           to an employee from an employer upon the employee's termination, resignation, retirement, or  
24           other separation from employment for accrued paid sick days that have not been used.

25           (f) Nothing in this section shall be construed to discourage employers from adopting or  
26           retaining paid sick time policies more generous than policies that comply with the requirements of  
27           this section, and nothing in this section shall be construed to diminish the obligation of an  
28           employer to comply with any contract, collective bargaining agreement, or any employment  
29           benefit program or plan that provides greater sick time leave rights to employees than the rights  
30           established under this section.

31           (g) This act provides minimum requirements pertaining to paid sick time and shall not be  
32           construed to preempt, limit, or otherwise affect the applicability of any other law, regulation,  
33           requirement, policy, agreement, or standard that provides for greater accrual or use by employees  
34           of sick time, whether paid or unpaid, or that extends other protections to employees.

35           (h) Employers who have a paid time-off leave policy shall not be required to modify that  
36           policy, if that policy offers an employee the option, at the employee's discretion, to take paid sick  
37           time that is at least equivalent to the amounts and for the same purposes and under the same  
38           conditions as provided under this section.

39           **"§ 95-31.6. Notification, posting, and records.**

40           Employers shall give notice that employees are entitled to paid sick time, the amount of paid  
41           sick time, and the terms of its use guaranteed under this section, that retaliation against employees  
42           who request or use paid sick time is prohibited, and that each employee has the right to file a  
43           complaint with the Commissioner of Labor or in the General Court of Justice if sick time as  
44           required by this Article is denied by the employer or the employee is retaliated against for  
45           requesting or taking paid sick time. Employers may comply with this section by supplying each of  
46           their employees with a notice in English and Spanish that contains the information required by this  
47           section or by displaying a poster in a conspicuous and accessible place in each establishment  
48           where the employees are employed which contains in English and Spanish all information  
49           required by this section.

50           **"§ 95-31.7. Enforcement.**

1       (a) The Commissioner shall enforce and administer the provisions of this Article, and the  
2 Commissioner or his or her authorized representative is empowered to hold hearings and to  
3 institute civil proceedings hereunder.

4       (b) The Commissioner or the Commissioner's authorized representative shall have the  
5 power to administer oaths and examine witnesses, issue subpoenas, compel the attendance of  
6 witnesses and the production of papers, books, accounts, records, payrolls, and documents, and  
7 take depositions and affidavits in any proceeding hereunder.

8       (c) Any employer who violates the provisions of this Article shall be liable to the  
9 employee or employees affected in the amount of their unpaid sick time as the case may be, plus  
10 interest at the legal rate set forth in G.S. 24-1 from the date each amount first came due.

11       (d) In addition to the amounts awarded pursuant to subsection (c) of this section, the court  
12 shall award liquidated damages in an amount equal to the amount found to be due as provided in  
13 subsection (c) of this section, provided that if the employer shows to the satisfaction of the court  
14 that the act or omission constituting the violation was in good faith and that the employer had  
15 reasonable grounds for believing that the act or omission was not a violation of this Article, the  
16 court may, in its discretion, award no liquidated damages or may award any amount of liquidated  
17 damages not exceeding the amount found due as provided in subsection (c) of this section.

18       (e) Action to recover such liability may be maintained in the General Court of Justice by  
19 any one or more employees.

20       (f) The court, in any action brought under this Article, may, in addition to any judgment  
21 awarded to plaintiff, order costs and fees of the action and reasonable attorneys' fees to be paid by  
22 the defendant. The court may order costs and fees of the action and reasonable attorneys' fees to be  
23 paid by the plaintiff if the court determines that the action was frivolous.

24       (g) The Commissioner is authorized to determine and supervise the payment of the  
25 amounts due under this section, including interest at the legal rate set forth in G.S. 24-1 from the  
26 date each amount first came due, and the agreement to accept such amounts by the employee shall  
27 constitute a waiver of the employee's right to bring an action under subsection (e) of this section.

28       (h) Actions under this Article must be brought within two years pursuant to G.S. 1-53.

29       (i) The rights and remedies created by this Article are supplementary to all existing  
30 common law and statutory rights and remedies.

31 **"§ 95-31.8. Rules.**

32 The Commissioner of Labor shall adopt rules to implement this Article.

33 **"§ 95-31.9. Severability.**

34 The provisions of this Article shall be severable, and if any phrase, clause, sentence, or  
35 provision is declared to be invalid or is preempted by federal law or regulation, the validity of the  
36 remainder of this Article shall not be affected thereby."

37 **SECTION 3.1.(b)** G.S. 95-241(a) reads as rewritten:

38 "(a) No person shall discriminate or take any retaliatory action against an employee because  
39 the employee in good faith does or threatens to do any of the following:

- 40 (1) File a claim or complaint, initiate any inquiry, investigation, inspection,  
41 proceeding or other action, or testify or provide information to any person with  
42 respect to any of the following:
  - 43 a. Chapter 97 of the General Statutes.
  - 44 b. ~~Article 2A~~ Article 2A, Article 3A, or Article 16 of this Chapter.
  - 45 c. Article 2A of Chapter 74 of the General Statutes.
  - 46 d. G.S. 95-28.1.
  - 47 e. Article 16 of Chapter 127A of the General Statutes.
  - 48 f. G.S. 95-28.1A.
  - 49 g. Article 52 of Chapter 143 of the General Statutes.
  - 50 h. Article 5F of Chapter 90 of the General Statutes.

- 1 (2) Cause any of the activities listed in subdivision (1) of this subsection to be  
2 initiated on an employee's behalf.
- 3 (3) Exercise any right on behalf of the employee or any other employee afforded by  
4 ~~Article 2A~~ Article 2A, Article 3A, or Article 16 of this Chapter, by Article 2A  
5 of Chapter 74 of the General Statutes, or by Article 52 of Chapter 143 of the  
6 General Statutes.
- 7 (4) Comply with the provisions of Article 27 of Chapter 7B of the General Statutes.
- 8 (5) Exercise rights under Chapter 50B. Actions brought under this subdivision shall  
9 be in accordance with the provisions of G.S. 50B-5.5."

10 **SECTION 3.1.(c)** This section becomes effective July 1, 2017, applies only to  
11 covered employment on or after that date, and does not apply to any collective bargaining  
12 agreement entered into before July 1, 2017, that is still in effect on that date.

### 13 INCREASE TIPPED MINIMUM WAGE

14 **SECTION 4.1.(a)** Effective January 1, 2017, until December 31, 2017,  
15 G.S. 95-25.3(f) reads as rewritten:

16 "(f) Tips earned by a tipped employee may be counted as ~~wages only up to the amount~~  
17 ~~permitted in section 3(m) of the Fair Labor Standards Act, 29 U.S.C. 203(m), if the tipped~~  
18 ~~employee is notified in advance, is permitted to retain all tips and the employer maintains accurate~~  
19 ~~and complete records of tips received by each employee as such tips are certified by the employee~~  
20 ~~monthly or for each pay period. Even if the employee refuses to certify tips accurately, tips may~~  
21 ~~still be counted as wages when the employer complies with the other requirements of this section~~  
22 ~~and can demonstrate by monitoring tips that the employee regularly receives tips in the amount for~~  
23 ~~which the credit is taken. wages only up to the amount of five dollars (\$5.00) per hour. Tip~~  
24 ~~pooling shall also be is~~ permissible among employees who customarily and regularly receive tips;  
25 however, no employee's tips may be reduced by more than fifteen percent (15%) under a tip  
26 pooling arrangement."

27 **SECTION 4.1.(b)** Effective January 1, 2018, G.S. 95-25.3(f), as amended by  
28 subsection (a) of this section, reads as rewritten:

29 "(f) Tips earned by a tipped employee ~~may be counted as wages only up to the amount of~~  
30 ~~five dollars (\$5.00) per hour. shall not be counted as wages. Tip pooling is permissible among~~  
31 employees who customarily and regularly receive tips; however, no employee's tips may be  
32 reduced by more than fifteen percent (15%) under a tip pooling arrangement."

### 33 WAGE THEFT

34 **SECTION 5.1.(a)** G.S. 95-25.2 reads as rewritten:

#### 35 "§ 95-25.2. Definitions.

36 ~~In this Article, unless the context otherwise requires:~~The following definitions apply in this  
37 Article:

- 38 (1) ~~"Agriculture" includes farming~~ Agriculture. – Farming in all its branches  
39 performed by a farmer or on a farm as an incident to or in conjunction with  
40 farming operations.
- 41 (2) ~~"Commissioner" means the Commissioner. – The Commissioner of Labor.~~
- 42 (3) ~~"Employ" means to Employ. – To suffer or permit to work.~~
- 43 (4) ~~"Employee" includes any Employee. – Any individual employed by an~~  
44 employer.
- 45 (5) ~~"Employer" includes any Employer. – Any person acting directly or indirectly~~  
46 in the interest of an employer in relation to an employee.
- 47 (5a) Employment status. – The status of an individual, under the usual common law  
48 rules applicable in determining the employee-employer relationship, as an

- 1            employee or as an independent contractor (or other individual who is not an  
2            employee).
- 3            (5b) Enterprise. – The related activities performed either through unified operations  
4            or common control by any person or persons for a common business purpose  
5            and includes all such activities whether performed in one or more  
6            establishments or by one or more corporate units but shall not include the  
7            related activities performed for such enterprise by an independent contractor or  
8            franchisee.
- 9            (6) ~~"Establishment"~~ Establishment. – A physical location where business  
10           is conducted.
- 11           (7) ~~"The Fair Labor Standards Act"~~ Fair Labor Standards Act. – The Fair  
12           Labor Standards Act of 1938, as amended and as the same may be amended  
13           from time to time by the United States Congress.
- 14           (8) ~~"Hours worked"~~ Hours worked. – All time an employee is  
15           employed.
- 16           (8a) Intentional. – The employer consciously committed the act which violated the  
17           statute.
- 18           (9) ~~"Payday"~~ Payday. – That day designated for payment of wages due  
19           by virtue of the employment relationship.
- 20           (10) ~~"Pay periods"~~ Pay periods. – May be daily, weekly, biweekly,  
21           semimonthly, or monthly.
- 22           (11) ~~"Person"~~ Person. – An individual, partnership, association,  
23           corporation, business trust, legal representative, or any organized group of  
24           persons. For the purposes of G.S. 95-25.2, G.S. 95-25.3, G.S. 95-25.14, and  
25           G.S. 95-25.20, it also means the State of North Carolina, any city, town, county,  
26           or municipality, or any State or local agency or instrumentality of government.  
27           The Government of the United States and any agency of the United States  
28           (including the United States Postal Service and Postal Rate Commission) are  
29           not included as persons for any purpose under this Article.
- 30           (12) ~~"Seasonal food service establishment"~~ Seasonal food service  
31           establishment. – A restaurant, food and drink stand or other establishment  
32           generally recognized as a commercial food service establishment, preparing and  
33           serving food to the public but operating 180 days or less per year.
- 34           (13) ~~"Seasonal religious or nonprofit educational conference center or a seasonal~~  
35           ~~amusement or recreational establishment"~~ Seasonal religious or  
36           nonprofit educational conference center or a seasonal amusement or  
37           recreational establishment. – An establishment which does not operate for more

41 (a) Any employer who violates the provisions of G.S. 95-25.3 (Minimum Wage),  
 42 G.S. 95-25.4 (Overtime), or G.S. 95-25.6 through 95-25.12 (Wage Payment) shall be liable to the  
 43 employee or employees affected in the amount of their unpaid minimum wages, their unpaid  
 44 overtime compensation, or their unpaid amounts due under G.S. 95-25.6 through G.S. 95-25.12, as  
 45 the case may be, plus interest at the legal rate set forth in G.S. 24-1, from the date each amount  
 46 first came due.

47 (a1) In addition to the amounts awarded pursuant to subsection (a) of this section, the court

 49 provided in subsection (a) of this section, provided that if the employer shows to the satisfaction of

35 (1) The claim shall include all of the applicable information set forth under

37 (2) The notice of lien shall be served on the property owner in the manner  
38 prescribed by G.S. 44A-11.

39 A lien under this section is perfected as soon as notice is provided as required by this subsection.

40 (g) In order to enforce a lien under this section upon personal property, the Commissioner,  
41 employee representative, or employee shall file the notice of the lien in the office of the Secretary  
42 of State and serve a copy of the notice by personal service to the employer in the same manner as a  
43 summons, or by mail. The office of the Secretary of State shall place the notice of the lien in the

In the judgment resulting from such an action, the court may order the sale at sheriff's auction or the transfer to the plaintiff of title or possession of any property subject to the lien. Whether or not the court makes such an order as part of the judgment, a writ of sale may be issued for any property subject to the lien at any point after a judgment for unpaid wages is issued.

(k) If judgment is entered in favor of the employer in an action for unpaid wages or if the case is dismissed with prejudice, the lien shall be extinguished upon expiration of the applicable appeals period if no appeal is filed. If an appeal is filed, the lien shall continue in force until all issues on appeal have been decided.

(l) If an action to recover the wages is not brought within one year of the filing of the lien, the lien created by this section shall be extinguished.

(m) A lien recorded pursuant to subsection (f) of this section takes precedence over all other debts, judgments, decrees, liens, or mortgages against the employer, regardless as to whether these debts, judgments, decrees, liens, or mortgages originate before or after the wage lien, and regardless of whether these debts, judgments, decrees, liens, or mortgages were perfected prior to the wage lien. An employee's lien is effective against the employer, the estate of the employer, or a subsequent bona fide purchaser of the property subject to the employee's lien.

(n) The employee, the Commissioner, or the employee's representative, as assignee of the employee, is entitled to court costs and reasonable attorneys' fees for filing a successful action to foreclose a lien pursuant to this section."

**SECTION 5.1.(f)** This section is effective when it becomes law and applies to employers and employees on or after that date.

**SECTION 6.1.(a)** Chapter 126 of the General Statutes is amended by adding a new Article to read:

### "Article 17.

#### "Fair Assessment of Persons with Criminal Histories.

#### **"§ 126-100. Definitions.**

The following definitions apply in this Article:

(1) Criminal history. – A State or federal history of conviction of a crime, whether a misdemeanor or felony, that bears upon an applicant's fitness for public employment. The term does not include a record of arrest not resulting in conviction.

(2) Hiring authority. – The agent responsible by law for the hiring of persons for public employment.

(3) Public Employment. – Any job, work for pay, or employment, including temporary or seasonal work, where the employer is the State of North Carolina or any local political subdivision of the State.

#### **"§ 126-101. Consideration of applicant criminal history.**

A hiring authority may not inquire into or consider the criminal history of an applicant for public employment, or include any such inquiry on any initial employment application form, until the hiring authority has made a conditional offer of employment to the applicant. This Article is not applicable to positions for which a hiring authority is otherwise required by law to consider the criminal record; however, nothing in this Article shall be construed to preclude any hiring authority in its discretion from adopting the provisions of this Article.

#### **"§ 126-102. Criteria for disqualification.**

(a) Except as otherwise required by law, no person shall be disqualified from public employment solely or in part because of a prior conviction, unless the conviction is determined to

1 be substantially related to the qualifications, functions, or duties of the position after consideration  
 2 of all of the following factors:

- 3 (1) The level and seriousness of the crime.
- 4 (2) The date of the crime.
- 5 (3) The age of the person at the time of the conviction.
- 6 (4) The circumstances surrounding the commission of the crime, if known.
- 7 (5) The nexus between the criminal conduct and the duties of the position.
- 8 (6) The prison, jail, probation, parole, rehabilitation, and employment records of  
 9 the person since the date the crime was committed.
- 10 (7) The subsequent commission of a crime by the person.

11 (b) A record of arrest not resulting in conviction may not be the basis for disqualification  
 12 from public employment.

13 **"§ 126-103. Opportunity to provide evidence of inaccuracy.**

14 The hiring authority must inform the individual of the potential adverse employment decision  
 15 based on the background check report prior to a final decision and must provide an opportunity to  
 16 demonstrate that he or she was not correctly identified in the background check report or that the  
 17 report is otherwise inaccurate.

18 **"§ 126-104. Data collection.**

19 The Office of State Personnel shall do the following:

- 20 (1) Record and log the positions that are statutorily required to conduct background  
 21 checks prior to a conditional offer of employment.
- 22 (2) Conduct quarterly reviews to determine compliance with this Article, and make  
 23 a report on all such reviews to the General Assembly annually.
- 24 (3) Collect, and make available to the public, data on:
  - 25 a. The number of applicants for public employment with criminal histories  
 26 given conditional offers of employment.
  - 27 b. The number of applicants for public employment with criminal histories  
 28 who are subsequently employed.
  - 29 c. The retention rate of public employees with criminal histories.

30 **"§ 126-105. Applicability.**

31 The provisions of this Article apply to all applicants for public employment."

32 **SECTION 6.1.(b)** G.S. 126-5 is amended by adding a new subsection to read:

 40 to any other qualifying individual, the applicable percentage is the appropriate percentage in the  
 41 column labeled "Percentage B" in the table below, based on the taxpayer's adjusted gross income  
 42 determined under the Code.

(b) Employment Related Expenses. – The amount of employment-related expenses for which a credit may be claimed may not exceed three thousand dollars (\$3,000) if the taxpayer's household includes one qualifying individual, as defined in section 21(b)(1) of the Code, and may not exceed six thousand dollars (\$6,000) if the taxpayer's household includes more than one qualifying individual. The amount of employment-related expenses for which a credit may be claimed is reduced by the amount of employer-provided dependent care assistance excluded from gross income.

(c) Limitations. – A nonresident or part-year resident who claims the credit allowed by this section shall reduce the amount of the credit by multiplying it by the fraction calculated under ~~G.S. 105-134.5(b) or (c)~~, G.S. 105-153.4(b) or (c), as appropriate. No credit shall be allowed under this section for amounts deducted in calculating North Carolina taxable income. The credit allowed by this section may not exceed the amount of tax imposed by this Part for the taxable year reduced by the sum of all credits allowable, except for payments of tax made by or on behalf of the taxpayer."

**SECTION 9.1.(b)** This section is effective for taxable years beginning on or after January 1, 2017.
