4	The General	The General Assembly of North Carolina enacts:		
5	SECTION 1. Chapter 246 of the Public-Local Laws of 1937 reads as rewritten:			
6	"AN ACT TO CREATE A FIRE DISTRICT FOR THE PURPOSE OF LEVYING TAXES			
7	THEREIN CONSISTING OF ROANOKE ISLAND OUTSIDE OF MANTEO AND			
8	AUTHORIZING COOPERATION WITH MANTEO IN FIRE PROTECTION.

10	"SECTION 3. That the Board of Commissioners of Dare County are authorized, empowered			
11	and directed to cause to be paid over to the governing authorities of the Town of Manteo-Roanoke			
12	Island Volunteer Fire Department or its successor all of the proceeds of taxes so levied and			
13	collected under the authority of this Act, and said taxes so levied and collected shall be used			
14 15	exclusively for said purpose.			
15 16	"SECTION 4. That the governing authorities of the Town of Manteo are That the Roanoke Island Volunteer Fire Department or its successor is authorized and empowered to receive the			
10	funds collected from taxes levied as aforesaid and use said funds exclusively for the purpose of			
18	providing fire equipment, maintaining same, and providing fire protection within the fire district			
19	herein organized, or using the same in conjunction with taxes levied and collected by the Town of			
20	Manteo and used for maintaining the fire department. The Town of ManteoRoanoke Island			
21	Volunteer Fire Department or its successor is hereby fully authorized and empowered to provide			
22		on within the said fire district and make provision for the purc	-	
23	-	equipment, which may be necessary for providing reasonable fire		
24		. Firefighting equipment purchased by funds from taxation within		
25	remain the pr	coperty of the said district and shall be plainly designated by proper 1	markings thereon	
26	indicating ownership thereof, but same shall be and remain in the custody and control of the Town			
27	of ManteoRe	oanoke Island Volunteer Fire Department or its successor for	use by its fire	
28	-	which shall serve jointly the Town of Manteo and said fire district.		
29	"SECTION 5. The governing authorities of the Town of Manteo The Roanoke Island			
30	Volunteer Fire Department or its successor shall annually on or before the first day of June in each			
31	year, make a report to the Board of Commissioners of Dare County, giving full information as to			
32	tunds receive	ed from the taxes herein levied and the use and application thereof,	, and shall at the	

same time furnish to the said Board of Commissioners of Dare County a report covering the
activities authorized by and under the provisions of this Act.
