SENATE BILL DRS35240-MTa-5B

Short Title: Add Homeschools to Opportunity Scholarship. (Public)

Sponsors: Senators Burgin and Krawiec (Primary Sponsors).

Referred to:

1 A BILL TO BE ENTITLED  
2 AN ACT TO PERMIT OPPORTUNITY SCHOLARSHIPS TO BE AWARDED TO  
3 STUDENTS IN HOME SCHOOL, TO PHASE IN INCREASED AWARD AMOUNTS  
4 FOR HOME SCHOOLERS OVER TIME, AND TO APPROPRIATE FUNDS FOR THAT  
5 PURPOSE.

6 The General Assembly of North Carolina enacts:

7 **SECTION 1.(a)** G.S. 115C-562.1 reads as rewritten:

8 "§ 115C-562.1. Definitions.

9 The following definitions apply in this Part:

- 10 (1) Authority. – The State Education Assistance Authority.  
11 (2) Division. – The Division of Nonpublic Education, Department of  
12 Administration.  
13 (3) Eligible students. – A student residing in North Carolina who has not yet  
14 received a high school diploma and who meets all of the following  
15 requirements:  
16 a. Meets one of the following criteria:  
17 1. Was a student (i) assigned to and attending a public school full  
18 time pursuant to G.S. 115C-366 or (ii) enrolled full time in a  
19 Department of Defense Elementary and Secondary School,  
20 established pursuant to 10 U.S.C. § 2164 and located in North  
21 Carolina, during the spring semester prior to the school year  
22 for which the student is applying.  
23 2. Received a scholarship grant for the school year prior to the  
24 school year for which the student is applying.  
25 3. Is eligible to enter kindergarten, first grade, or second grade  
26 pursuant to Article 25 of this Chapter. A child who is the age  
27 of four on or before April 16 is eligible to attend the following  
28 school year if the principal, or equivalent, of the school in  
29 which the child seeks to enroll finds that the student meets the  
30 requirements established by the Authority pursuant to  
31 G.S. 115C-562.2(d) and those findings are submitted to the  
32 Authority with the child's application.  
33 4. Is a child in foster care as defined in G.S. 131D-10.2(9).  
34 5. Is a child whose adoption decree was entered not more than  
35 one year prior to submission of the scholarship grant  
36 application.

- 1                                   6.     Is a child whose parent or legal guardian (i) is on full-time duty  
2   status in the active uniformed service of the United States,  
3   including members of the National Guard and Reserve on  
4   active duty orders pursuant to 10 U.S.C. § 12301, et seq., and  
5   10 U.S.C. § 12401, et seq., or (ii) receives an honorable  
6   discharge as an active duty member from the uniformed service  
7   of the United States within 12 months prior to application.
- 8                                   7.     Is a child who meets both of the following:  
9   I.     Was enrolled in a nonpublic school ~~that meets the~~  
10    ~~requirements of Part 1 and Part 2 of this Article~~ during  
11    the spring semester prior to the school year for which  
12    the student is applying.  
13    II.    Was enrolled for the entire school year immediately  
14    prior to the school year in which the student enrolled in  
15    the nonpublic school in one of the following:  
16    A.     A North Carolina public school.  
17    B.     A Department of Defense Elementary and  
18    Secondary School established pursuant to 10  
19    U.S.C. § 2164 and located in North Carolina.
- 20                                   a1.   Has not enrolled in a postsecondary institution in a matriculated status  
21   eligible for enrollment for 12 hours of academic credit.  
22                                   b.     Meets one of the following criteria:  
23   1.     Resides in a household with an income level not in excess of  
24   two hundred percent (200%) of the amount required for the  
25   student to qualify for the federal free or reduced-price lunch  
26   program. The Authority shall not count any distribution from  
27   the estate of a decedent in calculating the income level of the  
28   applicant's household for the purposes of determining  
29   eligibility for a scholarship under this sub-sub-subdivision.  
30   2.     Is a child in foster care as defined in G.S. 131D-10.2. The  
31   Authority shall not consider the household income of the foster  
32   parent, as defined in G.S. 131D-10.2, in determining the  
33   eligibility of a foster care child.
- 34                                   (3c)   Full-time student. – A student enrolled exclusively in a ~~nonpublic-private~~  
35   school for elementary or secondary education whose parents have released the  
36   local school administrative unit the student is eligible to attend under  
37   G.S. 115C-366 of all obligations to educate the eligible student while the  
38   eligible student is receiving a scholarship grant under this Part.
- 39                                   (3d)   Home school. – A nonpublic school that meets the requirements of Part 3 of  
40   Article 39 of this Chapter, as identified by the Division.
- 41                                   (4)     Local school administrative unit. – A local school administrative unit, charter  
42   school, or regional school.
- 43                                   (5)     Nonpublic school. – A school that meets the requirements of ~~Part 1 or Part 2~~  
44   Part 1, Part 2, or Part 3 of this Article as identified by the Division.
- 45                                   (5c)   Part-time student. – A student enrolled part time in a public school and part  
46   time in a ~~nonpublic-private~~ school.
- 47                                   (5d)   Private school. – A school that meets the requirements of Part 1 or Part 2 of  
48   this Article as identified by the Division.
- 49                                   (5e)   Reserve. – The Opportunity Scholarship Grant Fund Reserve established  
50   under G.S. 115C-562.8.

(6) Scholarship grants. – Grants awarded annually by the Authority to eligible students."

**SECTION 1.(b)** G.S. 115C-562.2 reads as rewritten:

**"§ 115C-562.2. Scholarship grants.**

...

(b) Scholarship grants ~~awarded to~~ shall be awarded, as follows:

(1) For eligible students in nonpublic schools residing in households with an income level not in excess of the amount required for the student to qualify for the federal free or reduced-price lunch program-program, the award amounts shall be, per year per eligible student, as follows:

a. For eligible students in private schools, in an amount of up to ninety percent (90%) as a full-time student or up to forty-five percent (45%) as a part-time student of the average State per pupil allocation for average daily membership in the prior fiscal year.

b. For eligible students in home schools, in an amount of up to one thousand dollars (\$1,000).

(2) Scholarship grants awarded to eligible students in nonpublic schools residing in households with an income level in excess of the amount required for the student to qualify for the federal free or reduced-price lunch program shall be for amounts of not more than ninety percent (90%) of the required tuition and fees as a full-time student or forty-five percent (45%) of the required tuition and fees as a part-time student for the nonpublic school the eligible child will attend.

(3) Tuition and fees for a nonpublic school may include tuition and fees for books, transportation, equipment, or other items required by the nonpublic school.

(4) No scholarship grant shall exceed, per year per eligible student, any of the following:

a. For students in private school, an amount equal to ninety percent (90%) for a full-time student or forty-five percent (45%) for a part-time student of the average State per pupil allocation for average daily membership in the prior fiscal year, and no year.

b. For students in home school, an amount equal to one thousand dollars (\$1,000).

(5) No scholarship grant shall exceed the required tuition and fees for the nonpublic school the eligible student will attend.

...."

**SECTION 1.(c)** G.S. 115C-562.4 reads as rewritten:

**"§ 115C-562.4. Identification of nonpublic schools and distribution of scholarship grant information.**

(a) The Division shall provide annually by February 1 to the Authority a list of all nonpublic schools operating in the ~~State that meet the requirements of Part 1 or Part 2 of this Article-State.~~ The Division shall notify the Authority of any schools included in the list that the Division has determined to be ineligible within five business days of the determination of ineligibility.

(b) The Authority shall provide information about the scholarship grant program to the Division, including applications and the obligations of ~~nonpublic-private~~ schools accepting eligible students receiving scholarship grants. The Division shall ensure that information about the scholarship grant program is provided to all qualified nonpublic schools on an annual basis."

**SECTION 1.(d)** G.S. 115C-562.5 reads as rewritten:

**"§ 115C-562.5. Obligations of ~~nonpublic-private~~ schools accepting eligible students receiving scholarship grants.**

- 1 (a) A ~~nonpublic-private~~ school that accepts eligible students receiving scholarship grants  
2 shall comply with the following:
- 3 (1) Provide to the Authority documentation for required tuition and fees charged  
4 to the student by the ~~nonpublic-private~~ school.
  - 5 (2) Provide to the Authority a criminal background check conducted for the staff  
6 member with the highest decision-making authority, as defined by the bylaws,  
7 articles of incorporation, or other governing document. Information provided  
8 to the Authority in accordance with this subdivision is privileged information  
9 and is not a public record but is for the exclusive use of the Authority.
  - 10 (3) Provide to the parent or guardian of an eligible student, whose tuition and fees  
11 are paid in whole or in part with a scholarship grant, an annual written  
12 explanation of the student's progress, including the student's scores on  
13 standardized achievement tests.
  - 14 (4) Administer, at least once in each school year, a nationally standardized test or  
15 other nationally standardized equivalent measurement selected by the chief  
16 administrative officer of the ~~nonpublic-private~~ school to all eligible students  
17 whose tuition and fees are paid in whole or in part with a scholarship grant  
18 enrolled in grades three and higher. For grades three through eight, the  
19 nationally standardized test or other equivalent measurement selected must  
20 measure achievement in the areas of English grammar, reading, spelling, and  
21 mathematics. For grades nine through 12, the nationally standardized test or  
22 other equivalent measurement selected must measure either (i) achievement  
23 in the areas of English grammar, reading, spelling, and mathematics or (ii)  
24 competencies in the verbal and quantitative areas. Test performance data shall  
25 be submitted to the Authority by July 15 of each year. Test performance data  
26 reported to the Authority under this subdivision is not a public record under  
27 Chapter 132 of the General Statutes.
  - 28 (5) Provide to the Authority graduation rates of the students receiving scholarship  
29 grants in a manner consistent with nationally recognized standards.
  - 30 (6) Contract with a certified public accountant to perform a financial review,  
31 consistent with generally accepted accounting principles, for each school year  
32 in which the school enrolls 70 or more students receiving scholarship grants  
33 or scholarship funds awarded by the Authority.
- 34 (b) A ~~nonpublic-private~~ school that accepts students receiving scholarship grants shall  
35 not require any additional fees based on the status of the student as a scholarship grant recipient.
- 36 (c) A ~~nonpublic-private~~ school enrolling more than 25 students whose tuition and fees  
37 are paid in whole or in part with a scholarship grant shall report to the Authority on the aggregate  
38 standardized test performance of eligible students. Aggregate test performance data reported to  
39 the Authority which does not contain personally identifiable student data shall be a public record  
40 under Chapter 132 of the General Statutes. Test performance data may be shared with public or  
41 private institutions of higher education located in North Carolina and shall be provided to an  
42 independent research organization selected by the Authority for research purposes as permitted  
43 by the Federal Education Rights and Privacy Act, 20 U.S.C. § 1232g.
- 44 (c1) A ~~nonpublic-private~~ school shall not discriminate with respect to the categories listed  
45 in 42 U.S.C. § 2000d, as that statute read on January 1, 2014.
- 46 (d) If the Authority determines that a ~~nonpublic-private~~ school is not in compliance with  
47 the requirements of this section, the ~~nonpublic-private~~ school shall be ineligible to receive future  
48 scholarship funds. The ~~nonpublic-private~~ school shall notify the parent or guardian of any  
49 enrolled student receiving a scholarship grant that the ~~nonpublic-private~~ school is no longer  
50 eligible to receive future scholarship grants. The Authority shall establish by rule a process for a  
51 ~~nonpublic-private~~ school to appeal for reconsideration of eligibility after one year. To ensure

1 compliance, the Board of Directors of the Authority shall review the criminal history provided  
2 under subdivision (2) of subsection (a) of this section to ensure that the person has not been  
3 convicted of any crime listed in G.S. 115C-332. The Board shall determine through this review  
4 whether the ~~nonpublic-private~~ school is noncompliant with this section. The Board shall make  
5 written findings with regard to how the criminal history information was used when making the  
6 compliance determination. The Board of Directors may delegate any of the duties in this  
7 subsection to the Executive Director of the Authority. As part of its review, the Board shall  
8 determine whether the results indicate that the staff member has any of the following  
9 disqualifying characteristics:

- 10 (1) Poses a threat to the physical safety of students or personnel.
- 11 (2) Demonstrates that he or she does not have the integrity or honesty to fulfill his  
12 or her duties in overseeing State funds and the requirements of the scholarship  
13 grant program.
- 14 (3) Has not fully satisfied the criminal sentencing obligations imposed following  
15 his or her conviction by a court of competent jurisdiction."

16 **SECTION 1.(e)** G.S. 115C-562.6 reads as rewritten:

17 **"§ 115C-562.6. Scholarship endorsement.**

18 The Authority shall remit, at least two times each school year, scholarship grant funds  
19 awarded to eligible students to the nonpublic ~~school-school~~. Scholarship grant funds awarded to  
20 eligible students to a private school shall be remitted for endorsement by at least one of the  
21 student's parents or guardians. The parent or guardian shall restrictively endorse the scholarship  
22 grant funds awarded to the eligible student for deposit into the account of the ~~nonpublic-private~~  
23 school to the credit of the eligible student. The parent or guardian shall not designate any entity  
24 or individual associated with the ~~nonpublic-private~~ school as the parent's attorney-in-fact to  
25 endorse the scholarship grant funds. A parent's or guardian's failure to comply with this section  
26 shall result in forfeit of the scholarship grant. A scholarship grant forfeited for failure to comply  
27 with this section shall be returned to the Authority to be awarded to another student."

28 **SECTION 1.(f)** G.S. 115C-562.7 reads as rewritten:

29 **"§ 115C-562.7. Authority reporting requirements.**

- 30 (a) Repealed by Session Laws 2014-100, s. 8.25(e), effective August 7, 2014.
- 31 (b) The Authority shall report annually, no later than October 15, to the Joint Legislative  
32 Education Oversight Committee on the following information from the prior school year:
  - 33 (1) Total number, grade level, race, ethnicity, and sex of eligible students  
34 receiving scholarship grants.
  - 35 (2) Total amount of scholarship grant funding awarded.
  - 36 (3) Number of students previously enrolled in local school administrative units or  
37 charter schools in the prior semester by the previously attended local school  
38 administrative unit or charter school.
  - 39 (4) Nonpublic schools in which scholarship grant recipients are enrolled,  
40 including numbers of scholarship grant students at each nonpublic school.
  - 41 (5) ~~Nonpublic-Private~~ schools deemed ineligible to receive scholarships.
- 42 (c) The Authority shall report annually, no later than December 1, to the Department of  
43 Public Instruction and the Joint Legislative Education Oversight Committee on the following:
  - 44 (1) Learning gains or losses of students receiving scholarship grants. The report  
45 shall include learning gains of participating students on a statewide basis and  
46 shall compare, to the extent possible, the learning gains or losses of eligible  
47 students by ~~nonpublic-private~~ school to the statewide learning gains or losses  
48 of public school students with similar socioeconomic backgrounds, using  
49 aggregate standardized test performance data provided to the Authority by  
50 ~~nonpublic-private~~ schools and by the Department of Public Instruction.

- 1 (2) Competitive effects on public school performance on standardized tests as a  
2 result of the scholarship grant program. The report shall analyze the impact of  
3 the availability of scholarship grants on public school performance on  
4 standardized tests by local school administrative units to the extent possible,  
5 and shall provide comparisons of the impact by geographic region and  
6 between rural and urban local school administrative units.

7 This report shall be conducted by an independent research organization to be selected by the  
8 Authority, which may be a public or private entity or university. The independent research  
9 organization shall report to the Authority on the results of its research. The Joint Legislative  
10 Education Oversight Committee shall review reports from the Authority and shall make ongoing  
11 recommendations to the General Assembly as needed regarding improving administration and  
12 accountability for ~~nonpublic-private~~ schools accepting students receiving scholarship grants."

13 **SECTION 2.** Effective July 1, 2024, G.S. 115C-562.2(b), as amended by Section 1  
14 of this act, reads as rewritten:

15 "(b) Scholarship grants shall be awarded, as follows:

- 16 (1) For eligible students in nonpublic schools residing in households with an  
17 income level not in excess of the amount required for the student to qualify  
18 for the federal free or reduced-price lunch program, the award amounts shall  
19 be, per year per eligible student, as follows:  
20 a. For eligible students in private schools, in an amount of up to ninety  
21 percent (90%) as a full-time student or up to forty-five percent (45%)  
22 as a part-time student of the average State per pupil allocation for  
23 average daily membership in the prior fiscal year.  
24 b. For eligible students in home schools, in an amount of up to ~~one~~  
25 ~~thousand dollars (\$1,000)~~ two thousand dollars (\$2,000).
- 26 (2) Scholarship grants awarded to eligible students in nonpublic schools residing  
27 in households with an income level in excess of the amount required for the  
28 student to qualify for the federal free or reduced-price lunch program shall be  
29 for amounts of not more than ninety percent (90%) of the required tuition and  
30 fees as a full-time student or forty-five percent (45%) of the required tuition  
31 and fees as a part-time student for the nonpublic school the eligible child will

- 33 (3) Tuition and fees for a nonpublic school may include tuition and fees for books,  
34 transportation, equipment, or other items required by the nonpublic school.

45 **SECTION 3.** Effective July 1, 2025, G.S. 115C-562.2(b), as amended by Section 2  
46 of this act, reads as rewritten:

47 "(b) Scholarship grants shall be awarded, as follows:

- 48 (1) For eligible students in nonpublic schools residing in households with an  
49 income level not in excess of the amount required for the student to qualify  
50 for the federal free or reduced-price lunch program, the award amounts shall  
51 be, per year per eligible student, as follows:

- 1 a. For eligible students in private schools, in an amount of up to ninety  
2 percent (90%) as a full-time student or up to forty-five percent (45%)  
3 as a part-time student of the average State per pupil allocation for  
4 average daily membership in the prior fiscal year.
- 5 b. For eligible students in home schools, in an amount of up to ~~two~~

26 **SECTION 4.** Effective July 1, 2026, G.S. 115C-562.2(b), as amended by Section 3  
27 of this act, reads as rewritten:

28 "(b) Scholarship grants shall be awarded, as follows:

- 29 (1) For eligible students in nonpublic schools residing in households with an  
30 income level not in excess of the amount required for the student to qualify  
31 for the federal free or reduced-price lunch program, the award amounts shall  
32 be, per year per eligible student, as follows:
- 33 a. For eligible students in private schools, in an amount of up to ninety  
34 percent (90%) as a full-time student or up to forty-five percent (45%)  
35 as a part-time student of the average State per pupil allocation for  
36 average daily membership in the prior fiscal year.
- 37 b. For eligible students in home schools, in an amount of up to ~~three~~  
38 ~~thousand dollars (\$3,000)~~ forty-five percent (45%) of the average  
39 State per pupil allocation for average daily membership in the prior  
40 fiscal year.
- 41 (2) Scholarship grants awarded to eligible students in nonpublic schools residing  
42 in households with an income level in excess of the amount required for the  
43 student to qualify for the federal free or reduced-price lunch program shall be  
44 for amounts of not more than ninety percent (90%) of the required tuition and  
45 fees as a full-time student or forty-five percent (45%) of the required tuition  
46 and fees as a part-time student for the nonpublic school the eligible child will  
47 attend.
- 48 (3) Tuition and fees for a nonpublic school may include tuition and fees for books,  
49 transportation, equipment, or other items required by the nonpublic school.
- 50 (4) No scholarship grant shall exceed, per year per eligible student, any of the  
51 following:

a. For students in private school, an amount equal to ninety percent (90%) for a full-time student or forty-five percent (45%) for a part-time student of the average State per pupil allocation for average daily membership in the prior fiscal year.

b. For students in home school, an amount equal to ~~three thousand dollars (\$3,000)~~ forty-five percent (45%) of the average State per pupil allocation for average daily membership in the prior fiscal year.

(5) No scholarship grant shall exceed the required tuition and fees for the nonpublic school the eligible student will attend."

**SECTION 5.(a)** There is appropriated the following amounts from the General Fund in the following years to be used for the purposes set forth in this act:

- (1) To the Board of Governors to be allocated to the State Education Assistance Authority, the sum of one hundred thirteen million dollars (\$113,000,000) in nonrecurring funds for the 2023-2024 fiscal year.
- (2) To the Opportunity Scholarship Grant Fund Reserve, the following amounts in additional recurring dollars for each of the following fiscal years:

**SECTION 5.(b)** G.S. 115C-562.8(b) reads as rewritten:

"(b) The General Assembly finds that, due to the critical need in this State to provide opportunity for school choice for North Carolina students, it is imperative that the State provide an increase of funds for 15 years to the Opportunity Scholarship Grant Fund Reserve. Therefore, there is appropriated from the General Fund to the Reserve the following amounts for each fiscal year to be used for the purposes set forth in this section:

For the 2032-2033 fiscal year and each fiscal year thereafter, there is appropriated from the General Fund to the Reserve the sum of ~~three hundred eleven million five hundred forty thousand dollars (\$311,540,000)~~ six hundred seventy-six million five hundred forty thousand dollars (\$676,540,000) to be used for the purposes set forth in this section. When developing the base budget, as defined by G.S. 143C-1-1, for each fiscal year specified in this subsection, the Director of the Budget shall include the appropriated amount specified in this subsection for that fiscal year."

**SECTION 6.** Section 1 of this act becomes effective June 30, 2023, and applies to applications for scholarship grants beginning with the 2023-2024 school year. Section 5 of this



1 act becomes effective July 1, 2023. Except as otherwise provided, this act is effective when it  
2 becomes law.
